Det. Garry has also told me that before asking me any questions I should understand I have the right to remain silent, and that any statements I make can be used against me in court. I also have the right to talk to a lawyer before and during any questions or have a lawyer present at any time. I've been told if I cannot afford a lawyer one would be furnished to me, and I have the right to remain silent until I have had a chance to speak with a lawyer. Det. CANDIES, I KNEW THERE WAS A PROBABILITY THAT JULIE WOULD REACT POORLY DUE TO THE FACT SHE HAS A PEANUT ALLERGY AND BEFORE GIVING HER THE CANDIES I READ THE PACKAGES WHICH STATED "MAY CONTAIN TRACE PEANUTS".

SINCE JULIE ATE THE CANDY SHE BEGAN TO HAVE A REACTION. I JUST WANTED TO REMIND HER FOR BEING A GOOD GIRL FOR BEING ON THE WEDDING PATH TO COMBAT THE REACTION I BEGAN TO GIVE JULIE LIQUID BENEDRYLL. HER EYES WERE PUFFY AND SHE COMPLAINED A BIT. I FINALLY PUT JULIE DOWN TO BED AT APPROXIMATELY 1:30AM WHEN SHE FELL ASLEEP I OPENED ONE OF HER EPI-PENS AND SHOT HER IN THE LEG WITH IT. I DID SO TO PREVENT ~~THE~~ AND MINIMIZE ALLERGIC REACTION.

WE BOTH FELL ASLEEP ON THE BED AND WHEN I WOKE AT APPROXIMATELY 6:30AM I WENT TO CHANGE JULIE'S DIAPER AND NOTICED SHE WAS COLORED AND OBVIOUSLY DEAD. I ATTEMPTED CPR WITH NEGATIVE RESULTS. ONCE I REALIZED JULIE HAD PASSED AWAY I BEGAN TO PANIC. I DIDN'T KNOW WHAT TO DO. I BECAME DESPAIRANT AND DECIDED I WOULD TAKE MY OWN LIFE. I WROTE A FOUR (4) PAGE NOTE

THE SAME NOTE DR. GREEN HAS SHOWN
ME, AND I HAVE INITIALED. I LAYED
THE NOTE, A BIBLE PASSAGE, AND SOME
OTHER ITEMS ON MY BED AND PREPARED
TO TAKE MY LIFE. FIRST I INJECTED
TWO DOSES OF TENSILIN INTO MY NECK,
THEN ONE INTO MY STOMACH. I DRANK
KYSOLINE, DIGESTA ZANAS AND OTHER
DRUGS. I THEN TOOK AN ASPIRIN COAT,
WRAPPED IT AROUND MY NECK AND
ASPHYXIATED MYSELF.

AT THIS TIME I KNEW I AM CONSCIOUS
AND SPEAKING WITH DR. JAMES GREEN AND
MONITOR WILHELM.

I REALIZE I SHOULDNT HAVE GIVEN JULIE
THE MM'S, I WAS JUST TRYING TO REWARD
HER, AND I KNEW THAT I SHOULD HAVE
TAKEN JULIE TO THE DOCTOR SINCE
I HAS ADMINISTERED THE EPI-INJECTION. MY
DOCTOR HAS ADVISED ME ON THE PAST THAT
A DOCTOR FOLLOW-UP IMMEDIATELY AFTER
EPI-INJECTION WAS NECESSARY.

DR. GREEN HAS ASKED ME IF I HAVE DONE
ANYTHING ELSE OTHER THAN THE EPI-INJECTION
AND MY ANSWER TO THAT QUESTION IS "No".
