I am Detective Sergeant C. Darrin Ritter of the Moore County Sheriff's Department. I have been an officer in Law Enforcement since 1988, and have worked various positions in police work. I worked in the patrol division for approximately six and half years, four years of which I was a supervisor with the Aberdeen Police Department. During that time I made approximately 200 drugs arrests and assisted in at least one successful undercover campaign. I was Chief of Police for one and half years with the Pinebluff Police Department. I was a Detective with the Southern Pines Police Department for approximately three years two months. In January of 1998 I was assigned to Narcotic's Division with the Southern Pines Police Department. In October 2000, I started to work with the Moore County Sheriff's Department Patrol Division. During this time I patrolled the County of Moore. In December 2002 I was promoted to Detective Sergeant with the Sheriff's Department, I am currently assigned to the Narcotic Division. In January 2008 I was promoted to Lieutenant over the Narcotics Division at the Moore County Sheriff's Office. I supervise seven other Detective Sergeants in the Narcotic Division. During my career in Law Enforcement, I have received approximately 1200 hours of Law Enforcement training. I have attended several schools and seminars conducted by the North Carolina Justice Academy, United States Department of Justice, the State Bureau of Investigation and various Community Colleges in North Carolina. I have been involved in at least 3 homicide investigations.

On 3/29/2009 I received a call to assist in a homicide investigation at the Pine Lake Nursing Center on Pinehurst Ave. Carthage, NC. During the course of the investigation the suspect Robert Kenneth Stewart was arrested for murder. The investigation showed that Robert Kenneth Stewart went to Pine Lake Nursing Center and shot and killed eight victims and shot and wounded Carthage Police Officer and another victim.

During the investigation Robert Kenneth Stewart made a statement to a Registered Nurse at First Health Moore Regional Emergency Department as that he had taken 6 nerve pills and he don't remember anything else.

I, George Kipling Dennis, am a Detective with the Moore County Sheriff's Office. I have been a sworn Deputy since July of 1999. Prior to joining the Sheriff's Office I was a patrol officer for two and a half years with the Southern Pines Police Department. During my employment as a law enforcement officer, I have received over 500 hours of law enforcement training. I have a Bachelor of Science degree in Criminal Justice from Appalachian State University and I have obtained my Advanced Certificate in law enforcement issued by the Sheriff's Training and Standards Commission of North Carolina. I have been personally involved in the investigation of more than 500 violations of the North Carolina Controlled Substance Act. I have been personally involved in more than 300 criminal investigations.

On Sunday March 29th, 2009 Officer Justin Garner of the Carthage Police Department responded to Pine Lake Health and Rehabilitation at 801 Pinehurst Avenue in Carthage after receiving a report of a shooting. Officer Garner engaged the shooting suspect, later identified as Robert Kenneth Stewart, and wounded the suspect. Officer Garner was also wounded by the suspect. Robert Kenneth Stewart was placed into custody and transported to First health of the Carolina's for medical attention. An investigation discovered that several people were shot by Robert Kenneth Stewart and that eight individuals died as a result of gunshots.

Monroe described the residence and directions to the residence as follows: from Carthage, travel on Glendon Carthage Road towards Glendon. At the intersection of Glendon Carthage Road and Carbonton Road, bear left onto Glendon Carthage Road towards Siler City.
